**PUBLIC COMMENT PERIOD**

A person addressing the Commission will be limited to a maximum of 3 minutes unless the Chairperson of the Commission grants a longer period of time. The Commission will only allow comments by members of the public on an item of the Agenda during consideration of the item.
